| 2 | What is the cost to become a corporate partner? | There is no cost to become a partner. |
| 3 | When will my partnership begin? | The partnership will begin upon receipt of the signed MOU and completed Questionnaire. |
| 4 | How long does the corporate partnership last? | The corporate partnership remains active indefinitely or until either party chooses to discontinue the relationship. |
| 5 | By becoming a corporate partner, are we agreeing to have our employees/members only enroll at CCU? | No, the partnership agreement is non-exclusive. It simply means that if any of your employees/members choose to become a student at our institution, they will receive the benefits included in the partnership agreement. |
| 6 | Can the corporate partnership discount be given retroactively to students already enrolled in the program? | The discount is only offered to students that enroll after the partnership agreement is signed and remain in active status. |
